### INVITATION TO SUBMIT BID PROPOSAL

To all Prospective Bidders:

Nueva Ecija II Electric Cooperative, Inc.-Area 1 (NEECO II-Area 1), in compliance with the guidelines of the Energy Regulatory Commission (ERC), Department of Energy (DOE) and National Electrification Administration (NEA), invites interested Power Generators to participate in the Competitive Power Supply Procurement (CPSP) for the Supply of Full Energy Requirements/Baseload and Intermediate Demand for a term of sixty (60) months commencing the period from December 26, 2020 to December 25, 2025.

The Competitive Selection Process is open to all new and existing Generation Sources that may fit to the requirement of NEECO II-Area 1 to bid for the following capacity and energy, to wit:

Interested parties must submit a notarized Letter of Intent (LOI) to the NEECO II-Area 1 Third Party Bids and Awards Committee (TPBAC). The LOI, signed by an authorized representative, shall state the full name, address, telephone, email address and fax numbers of the interested party and name of the principal contact. It must be delivered by hand and be received by the TPBAC at the NEECO II-Area 1 Main Office with address at Maharlika Highway, Calipahan, Talavera, Nueva Ecija not later than 5:00PM, on March 23, 2020.

The details of the Competitive Power Supply Procurement Package (Eligibility Requirements, Information Memorandum, and Instruction to Bidders) are contained in the Bidding Document which is downloadable in NEECO II-Area 1 website. Interested parties must purchase the bidding documents by paying a non-refundable fee of Seventy Five Thousand (Php75,000.00) on March 9, 2020 to March 23, 2020. Only interested parties or bidders who purchased the Bidding Documents will be allowed to participate in the pre-bid conference on March 18, 2020, at exactly 2:00 PM at Teofilo Villanueva Hall, NEECO II-Area 1 Main Office.

NEECO II-Area 1 reserves the right to annul or declare a failure of the Competitive Selection Process and reject all bids at any time prior to award of contract without incurring any liability to the affected bidder(s) or any obligation to inform the bidder(s) of the grounds for action, waive defects or infirmities therein and to accept such bid as may be considered most advantageous to NEECO II-Area 1.
